Other (as appropriate): Especially difficult seems to be collection of knowledge and data about the experience of countries with alternative measures of GDP.

Verbal assessment (several sentences), in particular: Subsection 2.1: The structure of the thesis is compact and coherent, with thorough but brief description of selected phenomena. Author aims to clarify and explain in detail all the relevant issues backed by appropriate argumentation. Nevertheless, I would suggest that in empirical part some sections could reflect even deeper insight, especially comparison of GDP to alternative measures, which would be appealing to the reader. Further, the lucidity of the thesis could be slightly alleviated by using third level of headings. However I would suggest that clarity of the whole text is still maintained due to author's visible to keep the main story line visible to the reader.  Subsection 2.5: The thesis is well aligned with relevant conclusions, which are linked to appropriate theoretical knowledge. Author provides arguments why alternative measures of

GDP should be rather complementary to standard measure of GDP, supported by the relevant literature.

Other (as appropriate): I especially appreciate informative value of figures, which compare similarities in measurement of GDP and selected alternative indicators and which were compiled by the author himself. The author utilizes literature resources up to date and provides very interesting and recent evidence of growing interest in alternative measures.

Subsection 3.2: Author has outlined his objective clearly in the beginning of the thesis, being the aim to search for alternative measures of GDP, their evaluation and suggestions related to their practical utilization with respect to standard measures of GDP.

Subsection 3.3: The objective of the thesis has been fulfilled and is according to expectations.

Subsection 3.5: Theoretical part is full of interesting aspects and I will just mention few of them. Specifically, the chapter about "Current problems and issues with the measurement of GDP" represents fruitful discussion (followed by illustrative examples) about selected phenomena, which do not enter into GDP, or they enter only partially in GDP or in some countries. Consequently, the author is mapping contemporary efforts of searching for alternative measures. In particular, the case of China, India and especially Bhutan or Australia are worth the attention and represent substantial value added of the thesis.

I would suggest that if the author had more time to elaborate practical part of the thesis, the outcome could be even more interesting. Notwithstanding, author provides the reader with thorough analysis of alternative measures such as United Nations Human Development Index, the Social Progress Index, the Environmental Performance Index, the Happy Planet Index, the Legatum Prosperity Index, the OECD Better Life Index or the World Happiness Index. The author deals with measurement issues and practical drawbacks of alternative indicators and consequently evaluates its ties to GDP with derivation of implications. I would like to emphasize especially author's contribution to discussion about GDP and its relevance in the world of digital technologies, which is highly topical. Additionally, author has provided the reader with the chapter, which appropriately links theoretical knowledge with relevant outcomes, which emerged in practical part.

Subsection 3.6: Conclusions represent substantial value added and at the same time are relevant, succinct and adequate. Alternative measures represent very important complementary element
