The author presented well her results and provided an objective evaluation of her findings including limitations of the research. The only disputable matter could be the incorporation of the chapter 6. I feel that the author could spend more time on data analysis rather than on this chapter. Nevertheless the chapter itself is well organized and has its value for the whole paper. My opinion only is, that it would deserve its own thesis. The author should rather expand the time scope of the analysis and focus on mutual relations between analysed indicators.	20	18
