## Overall evaluation and questions to be answered in the course of the defense:

The student decided to create a business plan for small-fruit crops production and distribution in Russia. Key product of the business will be honeysuckles and strawberries.

The thesis is divided into two parts - theoretical and practical. In the theoretical part student provides insights about structure of business plan and key analysis that should be used in the process of business plan creation.

In the practical part student describes key parts of business plan for the company Lonicera. In this part I especially appreciate detailed industry analysis.

The student used appropriate methods to fulfill the bachelor's thesis goal. Structure of the thesis is logical. Linguistic and terminological level of the thesis is appropriate. I would recommend better visual quality of some pictures or tables (for example on page 5, 27) to make the thesis easier to read.

I recommend the thesis to be defended. Final grading will depend on the course of the defense.

Questions to be answered:

- 1) On page 24 is stated that the power of buyers is relatively low. Please explain.
- 2) Please explain value proposition in long deferred payments. What will be the influence on CF? (p.27)
- 3) What are the conditions related to the government grant that was already received? (p. 35)
- 4) Please explain, how was seasonality reflected in sales forecast? Further comment on sources and assumptions for sales forecast? (p. 38-39)
- 5) Please comment on equity of RUB 19m. How was gorernment grant and leased land (p. 16) reflected on the Opening balance sheet? (p. 44)
- 6) Please comment on planned production capacity compared to break-even analysis results (p. 17, 45)
